Allegiant Air Announces Nonstop Service to Elmira, New York from Orlando Sanford

Sanford, FL, September 23, 2008 – Allegiant Air and Orlando Sanford International Airport (SFB) announced today scheduled, nonstop, low-fare service beginning November 14, 2008 to Elmira Corning Regional Airport (ELM), in Horseheads, New York. Located just north of the New York and Pennsylvania border, the airport is situated to conveniently serve the Southern Tier of Central New York and the Northern Tier of Central Pennsylvania. Allegiant Air is offering introductory fares as low as \$89* each-way to celebrate the convenient new service.

Service will operate twice weekly on Thursday and Sunday. Flights will depart Orlando Sanford at 7:00 a.m. and arrive at Elmira at 9:40 a.m. Return service will depart Elmira at 10:20 a.m. and arrive in Orlando Sanford at 12:55 p.m. (all flight times are local). Allegiant will utilize 150-seat, MD-80 series jet aircraft on the route.

Allegiant's \$89* one-way introductory fare is limited, not available on all flights and must be purchased by October 15, 2008, for travel through February 5, 2009. Offer not available November 26 through December 1, 2008 and December 20, 2008 through January 5, 2009. After the introductory fare period, regular one-way fares on the route start as low as \$109* one-way.
