Allegiant Air Announces Nonstop Service to Grand Rapids, Michigan from Orlando Sanford

Sanford, FL, November 12, 2008 – Allegiant Air and Orlando Sanford International Airport (SFB) announced today scheduled, nonstop, low-fare service beginning February 3, 2009 to Gerald R. Ford International Airport (GRR), in Grand Rapids, Michigan. Located nearby Interstates 96 and 196, the airport is ideally situated to serve all of West Michigan. Allegiant Air is offering introductory fares as low as \$89* each-way to celebrate the convenient new service.

Service will operate three times weekly on Tuesday, Thursday and Sunday. Flights will depart Orlando Sanford at 9:55 a.m. and arrive at Grand Rapids at 12:35 p.m. Return service will depart Grand Rapids at 1:15 p.m. and arrive in Orlando Sanford at 3:50 p.m. (all flight times are local). Allegiant will utilize 150-seat, MD-80 series jet aircraft on the route.

Allegiant's \$89* one-way introductory fare is limited, not available on all flights and must be purchased by December 3, 2008, for travel through April 30, 2009. After the introductory fare period, regular one-way fares on the route start as low as \$109* one-way. Offer is not available for travel February 13-16, 2009 and April 4 – 20, 2009.
