**Allegiant Air Announces Nonstop Service to Hagerstown, Maryland from Orlando Sanford**

**Sanford, FL, September 17, 2008** – Allegiant Air and Orlando Sanford International Airport (SFB) announced today scheduled, nonstop, low-fare service beginning November 14, 2008 to Hagerstown Regional Airport (HGR), in Hagerstown, Maryland. Located just off of Interstate-81, the airport is situated to conveniently serve the four-state region of Maryland, Pennsylvania, West Virginia and Virginia. Allegiant Air is offering introductory fares as low as \$89\* each-way to celebrate the convenient new service.

Service will operate twice weekly on Monday and Friday. Flights will depart Orlando Sanford at 5:00 p.m. and arrive at Hagerstown at 7:10 p.m. Return service will depart Hagerstown at 7:50 p.m. and arrive in Orlando Sanford at 9:55 p.m. (all flight times are local). Allegiant will utilize 150-seat, MD-80 series jet aircraft on the route.
