**Allegiant Announces Nonstop Service to Shreveport, Louisiana  
from Orlando Sanford**

**Sanford, FL, September 5, 2006** – Allegiant Air, LLC and Orlando Sanford International Airport (SFB) announced today scheduled, nonstop, low-fare service beginning November 15, 2006 to Shreveport Regional Airport (SHV), in Shreveport, Louisiana. Located minutes from Interstates 20 and 49, the airport is ideally located to serve Northwest Louisiana, Northeast Texas and Southwest Arkansas. Allegiant Air is offering introductory fares as low as \$59\* each-way, when booked through the company's website at [www.allegiantair.com](http://www.allegiantair.com).

Service will operate twice weekly on Wednesday and Saturday. Flights will depart Orlando Sanford at 8:30 a.m. and arrive in Shreveport at 9:40 a.m. Return service is scheduled to leave Shreveport at 10:15 a.m. and arrive at Orlando Sanford at 1:25 p.m. (all flight times are local). Allegiant will utilize 150-seat, MD-80 series jet aircraft on the route.
